Judge Benson also informed the Committee that she does a lot of Grant writing for our Court System.

Motion was made by Vice Chair Durkin with a second by Member Clark to allow Judge Benson to Contract with an Attorney's firm for appointed Public Defender's cases and to stay within budgeted fund. Motion carried on a voice vote.
